Thank you for your patience. I have now taken some advice and further considered the two documents listed below and unfortunately I do not think that it is appropriate to disclose them, due to the fact that they pertain to the details of the police search of Mr Marsh's land, not any personal data of your clients.

I know there were concerns raised about the methodology of the search – I can only reiterate that the company who were used, Alecto, are a service provider to the MPS and other police forces, and are accredited nationally to undertake this kind of work. In addition we also sought advice/peer review from the NCA. The lead archaeologist for this work held the following qualifications ; MSc in of Forensic Archaeology and Crime Scene Investigation; BA in Archaeology; and accredited by the Chartered Institute for Archaeologists. She also has over 12 years of field archaeology experience.

I hope this goes some way to allaying your clients' concerns around how the search was completed. Once again we are all truly sorry that we were unable to find Muriel's remains.
